3) NB: A fee of EUR 35 (DKK 260) shall be charged for countries where the European Commission has concluded, or is negotiating a visa facilitation agreement.

4) No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.

5) Where several documents are issued at the same time, a total fee of DKK 195 shall be charged.

6) Provided the request for VAT refund comprises several separate purchases, a fee of DKK 195 shall be charged per statement.

7) When several provisional passports or extension of passports are issued at the same time, a fee of DKK 2,150 shall be charged for the first passport and DKK 955 for subsequent passports.

8) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,075 shall be charged for the first passport and DKK 955 for subsequent passports.
